Communication is vital in patient-clinician relationships. Patients with limited English proficiency experience poor clinical outcomes, restricted access to care, and reduced satisfaction with their health services. 1,2,3 During the COVID-19 pandemic, language barriers' effects on uptake of public health and safety messaging underscored the importance of interpreters' roles in providing high-quality health care and access to information all patients need. This digital drawing shows an elder, masked Sikh community member who appears to be following COVID-19 safety precautions, despite language or cultural barriers. Her eyes suggest her cautious demeanor and perhaps curiosity about what the unmasked don't understand.
